RESOLUTION NO. 567-2025

DECLARING ORDINANCE NO. 25-02 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING NUMBERS 20, 28 AND 59 OF THE ANNEX "A" OF ORDINANCE NO. 24-11, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION OF TRICYCLES IN THE CITY OF SAN CARLOS, (PANGASINAN)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 25-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the power of the Sangguniang Panlungsod to enact ordinances and approve resolutions carries with it the power to amend, revoke, modify, or repeal the same and was enacted in accordance with Sections 129, 132 and 458 (a) (3) (i) (vi) of R.A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (a) and 188 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—
