### RESOLUTION NO. 569-2025

**DECLARING MUNICIPAL ORDINANCE NO. 06-2024 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE NEWLY-DESIGNED OFFICIAL FLAG OF THE MUNICIPALITY OF MANAOAG, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Municipal Ordinance No. 06-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 22(a)(3)(b) of R.A. No. 7160; and Section 2, Chapter VI and Sections 44 to 77 of R.A. No. 8491 or the Flag and Heraldic Code of the Philippines;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 06-2024 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled “An Ordinance adopting the newly-designed Official Flag of the Municipality of Manaoag, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
