### RESOLUTION NO. 570-2025

**DECLARING MUNICIPAL ORDINANCE NO. 5-S-2025 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING AN ANIMAL BITE TREATMENT CENTER UNDER THE MUNICIPAL HEALTH OFFICE IN THE MUNICIPALITY OF SAN FABIAN, PROVINCE OF PANGASINAN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Municipal Ordinance No. 5-S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 17(b)(2)(viii) of R.A. No. 7160; and R.A. No. 9482 or the Anti Rabies Act of 2007;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 5-S-2025 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled “An Ordinance establishing an Animal Bite Treatment Center under the Municipal Health Office in the Municipality of San Fabian, Province of Pangasinan and providing funds thereof” as within the conferred powers of the Sangguniang Bayan to enact;


