RESOLUTION NO. 571-2025

DECLARING MUNICIPAL ORDINANCE NO. 6-S-2025 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A FACILITY AT THE LOCAL CIVIL REGISTRY OFFICE OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN TO FACILITATE THE PROCESSING OF REQUEST FOR COPIES OF CIVIL REGISTRY DOCUMENTS (CRD) AT THE PHILIPPINE STATISTICS AUTHORITY (PSA) CERTIFICATIONS IN SECURITY PAPER THROUGH THE CIVIL REGISTRY SYSTEM INFORMATION TECHNOLOGY PROJECT (CRS-ITP) AND THE BATCH REQUEST SYSTEM (BREQS) APPLICATION SOFTWARE AND IMPOSING FEES FOR SERVICES RENDERED” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Municipal Ordinance No. 6-S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129 and 132 of R.A. No. 7160; and R.A. No. 9482 or the Anti Rabies Act of 2007;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 188 of R.A. No. 7160;
