DECLARING ORDINANCE NO. 02-2025 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE SEVENTEEN THOUSAND ONE HUNDRED THIRTY FOUR (17,134) SQUARE METERS LOT REGISTERED UNDER THE NAME DSC DEVELOPMENT INC., A DULY REGISTERED CORPORATION UNDER PHILIPPINE LAWS, LOCATED AT BARANGAY STA. MARIA, SAN JACINTO, PANGASINAN FROM AGRICULTURAL TO COMMERCIAL LAND FOR THE PROPOSED GENESIS SUBDIVISION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
