RESOLUTION NO. 574-2025

DECLARING MUNICIPAL ORDINANCE NO. 2025-06 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING THE TITLE AND SECTION I OF ORDINANCE NO. 02-2023 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Municipal Ordinance No. 2025-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the legislative body's power to enact and approve ordinances or resolutions carries with it the power to amend, revoke, modify, or repeal them. Repeal may either be expressed or implied, or it may be maintained that a mere amendment of an ordinance shall suffice. This freedom of LGUs to amend, revoke, or repeal their legislative enactments is consistently upheld by different authorities and various jurisprudence. This is a manifestation of the autonomy that the Local Government Code envisions;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-06 of the Sangguniang Bayan of San Jacinto, Pangasinan, entitled "An Ordinance amending the Title and Section I of Ordinance No. 02-2023 of the Sangguniang Bayan of San Jacinto, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
