RESOLUTION NO. 576-2025

DECLARING MUNICIPAL ORDINANCE NO. 03-04072025 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "AN ORDINANCE ALLOCATING ONE SLOT IN THE POZORRUBIO MUNICIPAL SCHOLARSHIP PROGRAM (PMSP) FOR QUALIFIED PERSONS WITH DISABILITIES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 03-04072025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province has conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (2)(iv) and 447 (5)(xi)(xiv) of R.A. No. 7160; R.A. No. 109311 or the Universal Access to Quality Tertiary Education Act; R.A. No. 10648 or the Iskolar ng Bayan Act of 2014; Article XIV, Section 1 of the 1987 Philippine Constitution; and R.A. No. 7277 or the Magna Carta for Disabled Persons;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 03-04072025 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled "An Ordinance allocating one slot in the Pozorrubio Municipal Scholarship Program (PMSP) for qualified Persons with Disabilities" as within the conferred powers of the Sangguniang Bayan to enact;
