**APPROVING RESOLUTION NO. 61, S-2025 OF THE SANGGUNIAN BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1, SERIES OF 2025 (SIP-01-2025) IN THE MUNICIPALITY OF STO. TOMAS, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 61, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Sto. Tomas, Pangasinan has identified items in their Supplemental Annual Investment Program No. 1. This was endorsed to the Sangguniang Bayan for approval on April 7, 2025 by the Municipal Development Council thru MDC Resolution 01-SS-2025 and was favorably acted upon by the Sangguniang Bayan on May 5, 2025 thru Resolution No. 61, Series of 2025;
2. The said SAIP covers fund augmentation for the purchase and installation of solar lights; and

3. Funding support for the full implementation of the same in the amount of Php1,000,000.00 is embodied in their Supplemental Budget No. 1 for CY 2025 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01, Series of 2025 on May 5, 2025.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sto. Tomas, Pangasinan;
