RESOLUTION NO. 579-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CALENDAR YEAR 2025 OF STO. TOMAS, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P1,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Supplemental Budget No. 01 for Calendar Year 2025 involving total appropriations of Php1,000.000.00, which was enacted on May 5, 2025 through Appropriation Ordinance No. 01, Series of 2025;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That the appropriation and utilization of the 5% LDRRMF shall be in accordance with NDRRMC-DBM-DILG JMC No. 2013-1, dated March 25, 2013, specifically Item 6.4 & 6.5 thereof;

- 3. That all procurements to be undertaken shall be subject to R.A. 9184 (Government Procurement Reform Act) and its Implementing Rules and Regulations and R.A. 12009 (The New Government Procurement Act of 2004); and
- 4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality and its Supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 01 for Calendar Year 2025 of Sto. Tomas, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Sto. Tomas, Pangasinan, for its information and guidance.
