#### RESOLUTION NO. 580-2025

APPROVING RESOLUTION NO. 717, S-2022-25 OF THE SANGGUNIANG PANLUNGSOD OF URDANETA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (CY 2025) OF THE CITY GOVERNMENT OF URDANETA AMOUNTING TO ONE BILLION EIGHT HUNDRED SIX MILLION, ONE HUNDRED FORTY-ONE THOUSAND THREE HUNDRED TWO PESOS ONLY (P1,806,141,302.00)"

WHEREAS, the Sangguniang Panlungsod of Urdaneta, Pangasinan submitted its Resolution No. 717, Series of 2022-25 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS,** the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator has conducted initial review and study on said Resolution with the following findings:

- 1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of the City of Urdaneta, Pangasinan has formulated the city's Annual Investment Program for Calendar Year 2025, which was endorsed to the Sangguniang Panlungsod for approval through MDC Resolution No. 05B-2024 dated September 6, 2024;
- The AIP of the city is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No.2015-01 dated July 23, 2015 as to

> format and content. The AIP of Urdaneta, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenses and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan and Anti-Drug Abuse Council Action Plan, Local Nutrition Action Plan, and Tourism/Cultural Development Plan, Local Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;

- 3. The proposed AIP with a total investment requirement of Php1,806,141,302.00 will be funded from the city's proposed 2025 Annual Budget, enacted on December 11, 2024 through Appropriation Ordinance No. 77, Series of 2022-25;
- 4. The development fund amounting to Php187,500,000.00 which is allocated for development projects is twenty percent (20%) of the city's NTA amounting to Php 937,345,590.00 for CY 2025. This is in accordance with Section 287 of RA 7160. The identified development programs/projects to be funded by the 20% of NTA are based on DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
- 5. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the city amounting to Php65,223,438.00 conforms with Section 21 of RA 10121. The 70% of the 5% LDRRMF amounting to Php45,656,406.60 is allocated for disaster risk reduction programs/projects while 30% with a total amount of Php19,567,031.40 is set aside for Quick Response Fund. The programs, projects and activities proposed to be funded from 70% of the 5% LDRRMF are based on NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan 2023-2028 of the City has been indorsed to the Office of the Civil Defense (OCD) for review;

- 6. The LGU has also identified programs/projects/activities responsive to climate change and tagged in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015. It is recommended however that amount of tagged Climate Change expenditures shall be identified;
- 7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the PCW-DILG-DBM-NEDA Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 25, 2024; and
- 8. The AIP 2025 of the city of Urdaneta also includes programs/projects proposed to be funded from external sources with a funding requirement of Php 324,385,599.00.

WHEREAS, the implementation of the Second Tranche Salary effective January 1, 2025 is not in accordance with the provisions of Item 5.5 of the LBC No. 160 dated August 12, 2024;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the City Government of Urdaneta, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was-

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 717, Series of 2022-25 of the Sangguniang Panlungsod of Urdaneta, Pangasinan, entitled "Approving the Annual Investment Program (CY 2025) of the City Government of Urdaneta amounting to One Billion Eight Hundred Six Million, One Hundred Forty-One Thousand Three Hundred Two Pesos only (P1,806,141,302.00)";
