#### **RESOLUTION NO. 584-2025**

#### DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2025 OF ASINGAN, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P130,000,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2025 involving total appropriations of Php130,000,000.00, which was enacted on April 2, 2025 through Appropriation Ordinance No. 2, Series of 2025;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017 dated March 8, 2007;
- 2. That the projects covered shall be consistent with/in accordance with the loan agreement between the Municipality of Asingan and the Land Bank of the Philippines; and

3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and R.A. 12009 (The New Government Procurement Act).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was-

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 2 for Calendar Year 2025 of Asingan, Pangasinan;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Asingan, Pangasinan, for its information and guidance.
