**PROVINCIAL RESOLUTION NO. 589-2025**

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION PANGASINAN SCHOOLS DIVISION II FOR THE ESTABLISHMENT OF MALICO EXTENSION LIBRARY LOCATED IN BARANGAY MALICO, SAN NICOLAS, PANGASINAN**

**WHEREAS**, Section 1 of Article XIV of the 1987 Philippine Constitution declares that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

**WHEREAS**, Republic Act 7743, otherwise known as "An Act Providing for the Establishment of Congressional, City and Municipal Libraries", promotes the moral and intellectual well-being of the people, elevate the literacy level of every Filipino to the end that illiteracy is eradicated, and recognizes the vital role of knowledge and information in nation building;

**WHEREAS**, Republic Act 9246, otherwise known as the "The Philippine Librarianship Act 2003", declares that the State recognizes the essential role of librarianship as a profession in developing the intellectual capacity of the citizenry thus making library service a regular component for national development;

**WHEREAS**, it is the objective of the Provincial Government of Pangasinan to promote reading and to increase awareness on the historical heritage of the Province of Pangasinan;

**WHEREAS**, the Provincial Government of Pangasinan, through the Pangasinan Provincial Library, intends to establish an extension library to provide free public library service to all community members of Barangay Malico, San Nicolas, Pangasinan;

**WHEREAS**, Malico Elementary School, under the jurisdiction of the Department of Education Pangasinan Schools Division Office 2, is the registered owner of a parcel of land covered by Tax Declaration No. 34-0015-05577, containing an area of Nine Thousand Nine-Hundred Ninety-Nine (9,999) square meters, more less, situated in Barangay Malico, San Nicolas, Pangasinan, which has a portion of lot which is currently vacant and deemed appropriate for the proposed public structure;

**WHEREAS**, in order to realize the foregoing goal, the Department of Education Pangasinan Schools Division Office II is allowing the Province of Pangasinan to use a portion consisting of Two Hundred (200) square meters of the land for period of twenty-five (25) years for the construction and operation of the Provincial Library extension;

**WHEREAS**, the terms and conditions of both parties are stipulated in the Memorandum of Agreement which shall form part of this resolution;

**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (1) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

**WHEREAS**, in view of the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Honorable Governor, Ramon V. Guico III, and the Department of Education Pangasinan Schools Division Office 2, represented by its Schools Division Superintendent, Ms. Vivian Luz S. Pagatpatan, CESO VI;

**WHEREFORE**, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Education Pangasinan Schools Division II for the establishment of Malico Extension Library located in Barangay Malico, San Nicolas, Pangasinan;

**RESOLVED, FINALLY**, that copies of this resolution be furnished to Honorable Governor Ramon V. Guico III, Province of Pangasinan, and Ms. Vivian Luz S. Pagatpatan, CESO VI, Schools Division Superintendent, Department of Education Pangasinan Schools Division II, for their information and guidance.
