PROVINCIAL RESOLUTION NO. 588-2025

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH BOUNTY CARES FOUNDATION, INC. FOR THE DONATION OF 2,000 KGS. OF DRESSED CHICKEN TO THE PROVINCE OF PANGASINAN

WHEREAS, Section 23 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes local chief executives, upon the authority of the Sanggunian, to negotiate and secure financial grants or donations in kind, in support of the basic services or to support facilities delivered by the province;

WHEREAS, the Sangguniang Panlalawigan of Pangasinan enacted Provincial Resolution No. 465-2023, dated May 22, 2023, authorizing the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Bounty Cares Foundation, Inc. for the donation of 2,000 kgs. of dressed chicken every month to the Province of Pangasinan;

WHEREAS, Bounty Cares Foundation, Inc., a socio-civic arm of Bounty Fresh Inc., aims to provide assistance and support through health and nutrition, education and scholarships, environment and disaster response programs and services to the different communities in the country;

WHEREAS, the Provincial Government of Pangasinan, through the Provincial Social Welfare and Development Office, regularly conducts its “Bantay Kalusugan Outreach Program”, which is designed to provide services and support directly to the target population in order to effectively resolve challenges concerning malnutrition and hunger in local communities;

WHEREAS, this initiative program by the Provincial Government of Pangasinan endeavors to promote and enhance social protection along with other health programs and services for the disadvantaged, vulnerable and marginalized sectors and communities in the Province;

WHEREAS, with its determination to further bring government services closer to the people, the Provincial Government of Pangasinan and Bounty Cares Foundation, Inc. mutually agree to continuously implement the Donation Program in the Province of Pangasinan, subject to the terms and conditions as stipulated in the MOA;

WHEREAS, the Province of Pangasinan, as project beneficiary of the Donation Program, through the Provincial Social Welfare and Development Office, shall receive 2,000 kgs. of dressed chicken monthly from the Bounty Cares Foundation, Inc. from July 1, 2025 to June 30, 2028;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (1) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;


WHEREAS, in view of the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by the Honorable Governor, Ramon V. Guico III, and the Bounty Cares Foundation, Inc., represented by its President, Mr. Tennyson G. Chen;

WHEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Honorable Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Bounty Cares Foundation, Inc. for the donation of 2,000 kgs. of dressed chicken to the Province of Pangasinan;
