PROVINCIAL RESOLUTION NO. 602-2025

ADOPTING AND APPROVING THE PUBLIC SERVICE CONTINUITY PLAN (PSCP) FOR THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Public Service Continuity Plan (PSCP) for the Province of Pangasinan, as duly adopted by the Provincial Disaster Risk Reduction and Management Council (PDRRMC) through PDRRMC Resolution No. 7, Series of 2025;

WHEREAS, the Public Service Continuity Plan (PSCP) is a strategic and operational all-hazards framework developed to ensure continuous delivery of essential public services during and after disruptions caused by natural or human-induced hazards, emergencies, pandemics, and other crises;

WHEREAS, the Plan outlines essential functions, identifies key personnel and resources, establishes communication protocols, and sets forth recovery strategies to mitigate operational losses, ensure leadership succession, and promote sustainable continuity capabilities of all government institutions;

WHEREAS, Section 12(c) of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates that the Local Disaster Risk Reduction and Management Office (LDRRMO) shall continuously undertake all necessary measures to maintain and ensure the availability of adequately trained and competent personnel for the effective implementation of civil defense and disaster risk reduction and management functions;

WHEREAS, the Province of Pangasinan, under the leadership of the Honorable Governor Ramon V. Guico III, has approved the Public Service Continuity Plan (PSCP) as a proactive measure to strengthen institutional readiness and ensure the continued delivery of vital services amidst various forms of disruption;
