PROVINCIAL RESOLUTION NO. 603-2025

MANDATING THE ESTABLISHMENT OF ALTERNATIVE EMERGENCY OPERATIONS CENTER (EOC) IN THE WESTERN AND EASTERN PANGASINAN TO STRENGTHEN PUBLIC SERVICE CONTINUITY AND DISASTER RESILIENCE

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the establishment of Alternative Emergency Operations Center (EOC) in the Western and Eastern Pangasinan as adopted by the Provincial Disaster Risk Reduction and Management Council through PDRRMC Resolution No. 8, S-2025;

WHEREAS, the establishment of Alternative Emergency Operations Center (EOC) in the Western and Eastern Pangasinan is designed to focus on policies and measures that will ensure the continuity of operations and prevent any disruption in the event of an emergency or disaster;

WHEREAS, said Operations Center will also act as fully functional backups for command-and-control operations in the Province of Pangasinan;

WHEREAS, in line with the objective of the Province of Pangasinan to protect the lives, livelihood and infrastructure of its community members, and consistent with the provisions of Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, the Provincial Government, through the Provincial Disaster Risk Reduction and Management Office, has established the Operations Center (OpCen), a centralized facility which serves as the nerve center for multi-agency and multi-level operational coordination response and resource mobilization and information management;

WHEREAS, the Sangguniang Panlalawigan recognizes that such establishment of an alternative emergency operations center in the Province is essential as it will serve as a secondary location to manage emergencies when the primary Emergency Operations Center is unavailable;
