RESOLUTION NO. 605-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2025 OF AGNO, PANGASINAN, INVOLVING A TOTAL APROPRIATION OF P13,950.000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 01 for CY 2025 involving total appropriations of P13,950,000.00, which was enacted on April 28, 2025 through Appropriation Ordinance No. 01-2025;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations & R.A. No. 12009 (The New Government Procurement Act);

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2025 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
3. That the purchase of vehicle shall be in accordance with the provisions of DBM Budget Circular No. 2022-1 dated February 1, 2022 (Omnibus Guidelines of the Acquisition, Use, Rental and Replacement of Government Motor Vehicles);
4. That the appropriation for Medical Allowance shall be in accordance with the provisions of Budget Circular No. 2024-6 dated December 12, 2024; and
5. That the disbursement of Share of Fire Code Fees shall be in accordance with DBM-DILG-DOF Joint Memorandum Circular No. 1, S-2023 dated April 17, 2023.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2025 of Agno, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Agno, Pangasinan, for its information and guidance.
