#### **RESOLUTION NO. 608-2025**

DECLARING MUNICIPAL ORDINANCE NO. 1, S-2025 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 1 AND 7 OF MUNICIPAL ORDINANCE NO. 12, SERIES OF 2023, "AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO ALL FARMERS IN THE MUNICIPALITY OF MABINI, AND APPROPRIATING THE NECESSARY FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 1, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 447 (a)(1)(iii) of Republic Act No. 7160, and Republic Act No. 11321, otherwise known as the "Sagip Saka Act";

WHEREAS, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to provide an appropriation for the implementation of the subject ordinance to ensure the execution of said noble legislation;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
