RESOLUTION NO. 610-2025

DECLARING ORDINANCE NO. 097-2025 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR THE GENERAL POLICY ON THE MANUFACTURE, SALE, DISTRIBUTION AND USE OF FIRECRACKERS, FIREWORKS AND OTHER PYROTECHNIC DEVICES IN THE MUNICIPALITY OF LABRADOR, PANGASINAN PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Ordinance No. 097-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16 and 477 (1) (ii) and (iii) of R.A. No. 7160, and R.A. No. 7183 or the Act Regulating the Sale, Manufacture, Distribute and Use of the Firecrackers and Other Pyrotechnic Devices;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
