#### **RESOLUTION NO. 612-2025**

DECLARING ORDINANCE NO. 24-23 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "AN ORDINANCE IMPLEMENTING PHILIPPINE ANIMAL WELFARE ACT, ESTABLISHING AN ANIMAL WELFARE COMMITTEE, AN IMPOUNDING FACILITY, AND DESIGNATING FOCAL PERSON AND ANIMAL WELFARE ENFORCEMENT OFFICERS, DEFINING THEIR FUNCTIONS AND COMPOSITIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 24-23 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991:

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 17 (b) (2) (viii) of R.A. No. 7160 and R.A. No. 8485, or the Animal Welfare Act of 1998;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
