PROVINCIAL RESOLUTION NO. 628-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH CYDEN MEDICALE TRADING, INC. FOR THE PROVISION, INSTALLATION, COMMISSIONING, OPERATION AND MAINTENANCE OF FIFTEEN (15) BRAND NEW DIALYSIS MACHINES TO BE LOCATED AT THE EASTERN PANGASINAN DISTRICT HOSPITAL

WHEREAS, Article 2, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Province of Pangasinan has been continuously initiating to further rehabilitate and upgrade its fourteen provincial government hospitals in order to deliver quality health programs and medical services for all Pangasinenses, especially the underprivileged;

WHEREAS, with the increasing number of financially challenged patients needing dialysis treatment, the Cyden Medicales Trading, Inc. has offered to the Provincial Government of Pangasinan, through Eastern Pangasinan District Hospital, to provide fifteen (15) Brand New Dialysis Machines for free, including the regular, quarterly and annual preventive maintenance of said dialysis machines;

WHEREAS, the Provincial Government of Pangasinan shall, in turn, exclusively purchase from Cyden Medicales Trading, Inc. consumables necessary for the use and operation of said machines during the seven-year agreement period, subject to the terms and conditions as stipulated in the MOA;

WHEREAS, said high-quality medical equipment could further improve the healthcare services and programs needed by patients patronizing at the Eastern Pangasinan District Hospital;

WHEREAS, this Program is in consonance to RA 11223 or the Universal Health Care Act of 2019 which mandates the implementation of health reform program in order to ensure that every Filipino is guaranteed an equitable access to quality and affordable healthcare services and is protected against financial risks;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (b) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be signed and entered into between the Province of Pangasinan, represented by Provincial Governor Ramon V. Guico III, and Cyden Medicales Trading, Inc., represented by its President, Mark Cyrill P. Vicente;

WHEREFORE, on motion of Acting Floor Leader Napoleon C. Fontelera, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with Cyden Medicales Trading, Inc. for the provision, installation, commissioning, operation and maintenance of Fifteen (15) Brand New Dialysis Machines to be located at the Eastern Pangasinan District Hospital;

RESOLVED, FURTHER that copies of this resolution be furnished to Provincial Governor Ramon V. Guico III, Province of Pangasinan, and President Mark Cyrill P. Vicente, Cyden Medicales Trading, Inc., for their information and guidance.
