**PROVINCIAL RESOLUTION NO. 632-2025**

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH CORDILLERA SCHOOL OF DIGITAL ARTS (CSDA) FOR THE ESTABLISHMENT OF A COLLABORATIVE PARTNERSHIP ON TECHNICAL-VOCATIONAL AND DIGITAL ART PROGRAMS**

**WHEREAS**, it is enshrined in Section 1 of Article XIV of the 1987 Constitution that the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all;

**WHEREAS**, one of the primary thrusts of the Provincial Government of Pangasinan is to provide access to free and quality higher and technical-vocational education to its constituents;

**WHEREAS**, the Province of Pangasinan, through the PPC, the first-ever tertiary learning institution owned by the province, seeks to establish collaborative partnerships with centers of learning such as the Cordillera School of Digital Arts;

**WHEREAS**, in its continuing efforts to enhance technical-vocational programs, the Provincial Government recognizes the need to partner with CSDA, a TESDA-certified institution based in Baguio City;

**WHEREAS**, CSDA offers a curriculum designed to provide comprehensive education in various fields of digital arts, including animation, graphic design, and video production;
