Said Appropriation Ordinance involves total appropriations of P128,525,990.79.

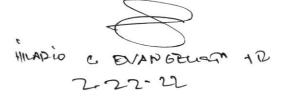

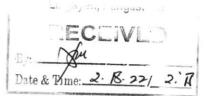
