RESOLUTION NO. 669-2025

DECLARING ORDINANCE NO. 24-26 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE PROVINCIAL ORDINANCE NO. 329-2024, ENTITLED: “AN ORDINANCE INSTITUTIONALIZING THE NATIONAL IMMUNIZATION PROGRAM (NIP) REACHING EVERY PUROK (REP) STRATEGY IN THE PROVINCE OF PANGASINAN, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES” IN THE CITY OF SAN CARLOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 24-26 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii), 458 (a) (5) (xiv) of Republic Act No. 7160; Section 15, Article II (Principles) and Section 11, Article XIII (Health) of the Philippine Constitution; Republic Act No. 10152 or the “Mandatory Infants and Children Health Immunization Act of 2011;

WHEREAS, the ordinance provided for the budgetary appropriations for the implementation of the program, such shall automatically be included in the Annual Budget of the city in the subsequent years for the enforcement of said ordinance;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 24-26 of the Sangguniang Panlungsod of San Carlos, Pangasinan, entitled “An Ordinance Adopting the Provincial Ordinance No. 329-2024, Entitled: “An Ordinance institutionalizing the National Immunization Program (NIP) Reaching Every Purok (REP) Strategy in the Province of Pangasinan, providing funds therefor, and for other purposes” in the City of San Carlos, Pangasinan” as within the conferred powers of the Sangguniang Panlungsod to enact;
