**PROVINCIAL RESOLUTION NO. 710-2025**

**CONDEMNING IN THE STRONGEST SENSE THE MURDER OF 7-YEAR-OLD ALLERIA GABRIELLE “PORTIA” JAMIAS OF BARANGAY BANTOG, ASINGAN, PANGASINAN AND URGING THE PANGASINAN POLICE PROVINCIAL OFFICE AND OTHER LAW-ENFORCEMENT AGENCIES TO FAST-TRACK THE EARLY RESOLUTION OF THE CRIME**

**WHEREAS**, on the early morning of Friday, August 15, 2025, the lifeless body of Alleria Gabrielle “Portia” Jamias was discovered along the shore of Barangay Bonuan Gueset, Dagupan City, following her disappearance on August 14, 2025 in Barangay Bantog, Asingan, Pangasinan;

**WHEREAS**, known to her loved ones as Portia, she was described as a bright, loving, and sweet little girl by the family and friends who cherished her;

**WHEREAS**, the Sangguniang Panlalawigan condemns, in the strongest possible terms, the killing of Portia, as this inhumane and senseless act of violence has no place in any civilized society, and no cause could ever justify the brutality she endured;

**WHEREAS**, Portia’s tragic and untimely death has left her family, friends, and the entire province in deep grief, and stands as a painful reminder of the urgent need to protect the safety and dignity of every child;

**WHEREAS**, the Sangguniang Panlalawigan implores that law enforcement agencies exert all efforts to bring the perpetrators to justice not only for the sake of Portia and her family but also to ensure that the rule of law is upheld at all times for an orderly and peaceful society;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Noel Fernando R. Bince, Jr., duly seconded, it was –


