PROVINCIAL RESOLUTION NO. 818-2025

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2025

WHEREAS, presented for consideration is the Supplemental Investment Program No. 3 of the Province of Pangasinan for Calendar Year 2025 as endorsed by the Provincial Development Council through PDC Resolution No. 03, S-2025;

WHEREAS, Supplemental Investment Program No. 3 contains other priority programs, projects and activities that are not included in the approved 2025 Annual/Supplemental Investment Program of the Province of Pangasinan;

WHEREAS, programs and projects included in the Supplemental Investment Program covers the Reconstruction of Lunec Bridge at Malasiqui, Pangasinan proposed to be funded from available DOE ER 1-94 Development and Livelihood Fund (DLF) of Sual Power, Inc. to provide a safer and more reliable means of passage of cargoes, people and commuters;

WHEREAS, also included in the Supplemental Investment Program is the purchase of 1-unit Coaster service vehicle to be used during the conduct of medical missions, public and social health care services to be funded from available DOE ER 1-94 Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF) of Sual Power, Inc.;

WHEREAS, the Supplemental Investment Program likewise includes the details of infrastructure projects funded from continuing and current appropriations;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

NOW, THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –


