**RESOLUTION NO. 819-2025**

**DECLARING ORDINANCE NO. 2025-10 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE 2025 SANITATION CODE OF THE CITY OF ALAMINOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2025-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160; Republic Act No. 10611 or the “Food Safety Act of 2013; Republic Act No. 9275 or the “Philippine Clean Water Act of 2004; and Republic Act No. 9003 or the “Ecological Solid Waste Management Act of 2000”;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2025-10 of the Sangguniang Panlungsod of **Alaminos**, Pangasinan, entitled “An Ordinance Enacting the 2025 Sanitation Code of the City of Alaminos, Pangasinan” as within the conferred powers of the Sangguniang Panlungsod to enact;


