RESOLUTION NO. 821-2025

APPROVING RESOLUTION NO. 229, S-2025 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED “APROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2025 OF THE MUNICIPALITY OF BINMALEY, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 229, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Binmaley, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 1 CY 2025. This was endorsed to the Sangguniang Bayan for approval on August 18, 2025 by the Municipal Development Council through Resolution No. 1, Series of 2025;
2. Said SIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of some municipal government offices, and other priority development programs/projects of the LGU;

3. The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1, dated November 4, 2020, (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
4. Funding support for the implementation of the same in the amount of PhP69,618,244.31 is embodied in their proposed Supplemental Budget No. 1 for Calendar Year 2025 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, Series 2025 on August 19, 2025.



WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


