RESOLUTION NO. 832-2025

APPROVING SB RESOLUTION NO. 180-2025 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FY 2025 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Resolution No. 180-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council identified items for inclusion in their Supplemental Investment Program No. 2 for CY 2025. This was endorsed by the Municipal Development Council to the Sangguniang Bayan on May 30, 2025, through MDC Executive Committee Resolution No. 05, Series 2025; and
2. Said Supplemental AIP, which has a total investment requirement of P326,777,258.00, covers the Development of a Level III Water Supply System proposed to be funded from External Funding through PPP and the Purchase of Patrol Vehicle for the PNP Mangatarem proposed to be funded from the Seal of Good Local Governance Incentive Fund 2024 of the LGU Mangatarem.

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


