RESOLUTION NO. 833-2025

APPROVING SB RESOLUTION NO. 193-2025 OF THE SANGGUNIANG BAYAN OF MANGATAREM, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FY 2025 OF THE MUNICIPALITY OF MANGATAREM, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Resolution No. 193-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council identified items for inclusion in their Supplemental Annual Investment Program No. 3 for FY 2025. This was endorsed by the Municipal Development Council to the Sangguniang Bayan on July 18, 2025, through MDC Executive Committee Resolution No. 06, Series 2025;
2. Said Supplemental AIP, covers the augmentation of funds for Personal Services (granting of Performance-Based Bonus to qualified municipal officials and employees and other benefits), Maintenance and Other Operating Expenses (MOOE), and Capital Outlay (CO) of some municipal offices, and the implementation of various development projects and programs for health sector of the LGU; and

3. Funding support for the full implementation in the amount of P48,422,793.33 is embodied in the Municipality's Supplemental Budget No. 01 for CY 2025 which was enacted by the Sangguniang Bayan on July 29, 2025 through Appropriation Ordinance No. 01, Series of 2025 in the amount of P38,802,733.33. The remaining P2,500,000.00 will be sourced from the LGU Support to the Barangay Development Program (SBDP) NTF-ELCAC in accordance with Local Budget Circular No. 162, dated February 24, 2025 "Guidelines on the Release and Utilization of the Local Government Support Fund Support to the Barangay Development Program (LGSF-SBDP) of the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) under the FY 2025 GAA, R.A. No. 12116". Meanwhile, the P7,120,060.00 will be funded from the Capitation Fund (Philhealth Trust Fund Hospital Charges RHU I and RHU II) of the LGU.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangatarem, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


