RESOLUTION NO. 840-2025

APPROVING RESOLUTION NO. 2025-130 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 3, CY 2025 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2025-130 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Mangaldan, Pangasinan has identified items in their Supplemental Investment Program (SIP) No. 3, CY 2025. This was endorsed to the Sangguniang Bayan for approval on August 5, 2025, by the Municipal Development Council through MDC Resolution No. 5, Series of 2025;
2. Said Supplemental AIP, which has an investment requirement of P3,000,000.00, covers the purchase of 1-unit multi-purpose vehicle of the LGU; and

3. Funding for the full implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3, CY 2025, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2025-03 dated August 11, 2025 and approved by the Municipal Mayor on August 26, 2025.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


