PROVINCIAL RESOLUTION NO. 857-2025

RESPECTFULLY URGING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO REQUEST THE OFFICE OF THE PRESIDENT TO DECLARE APRIL 22, 2026 AS A SPECIAL NON-WORKING HOLIDAY OF PRAYER AND THANKSGIVING IN THE PROVINCE OF PANGASINAN IN CELEBRATION OF THE CENTENNIAL ANNIVERSARY OF THE CANONICAL CORONATION OF OUR LADY OF THE ROSARY OF MANAOAG

WHEREAS, Our Lady of the Rosary of Manaoag is the venerated patroness of the Province of Pangasinan, deeply revered by millions of devotees from all over the country and abroad, and recognized as a powerful symbol of faith, hope, and unity among Pangasinenses;

WHEREAS, the image of Our Lady of the Rosary of Manaoag was canonically crowned by authority of Pope Pius XI on April 22, 1926, marking it as one of the first Marian image in the Philippines to receive such honor from the Holy See;

WHEREAS, the year 2026 marks the Centennial Jubilee of the Canonical Coronation of Our Lady of Manaoag, a once-in-a-lifetime spiritual milestone that calls for thanksgiving, renewal of faith, and commemoration by the faithful;

WHEREAS, the Minor Basilica of Our Lady of the Rosary of Manaoag, together with the Archdiocese of Lingayen-Dagupan, the Provincial Government of Pangasinan and the Municipality of Manaoag, have lined up significant religious, cultural, and civic activities to celebrate this momentous event;

WHEREAS, declaring April 22, 2026 as a special non-working holiday of Thanksgiving and Prayer in Pangasinan will allow the faithful and all Pangasinenses to meaningfully participate in the centennial celebration and pay homage to the Blessed Mother, whose intercession has long been regarded as a source of protection and blessings for the province;
