**DECLARING THE SUPPLEMENTAL BUDGET NO. 02 FOR
CALENDAR YEAR 2025 OF STO. TOMAS, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P4,373,837.76,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2025 involving total appropriations of Php4,373,837.76, which was enacted on September 1, 2025 through Appropriation Ordinance No. 02, Series 2025;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings shall be in accordance with the provision of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That the implementation of the Second Tranche Salary Adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 165 dated July 18, 2025 re: Implementation of the Second Tranche of the Updated Salary Schedule for Local Government Personnel pursuant to Executive Order (EO) No. 64, s. 2024, specifically Item 5.0 thereof and shall be subject to Sec. 325 (a) of R.A. 7160;
4. That the appropriation for Other Personnel Benefits shall only be disbursed upon issuance of circulars by proper authority granting the same;
5. That the grant of Year-End Bonus shall be subject to the provisions of Budget Circular No. 2016-4 of the Department of Budget and Management dated April 28, 2016;
6. That all procurements to be undertaken shall be subject to the provisions of existing laws, rules and regulations; and
7. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality and its Supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 2 for Calendar Year 2025 of Sto. Tomas, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Sto. Tomas, Pangasinan, for its information and guidance.
