**PROVINCIAL RESOLUTION NO. 882-2025**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A CONTRACT WITH REGIONAL NEWS GROUP (RNG) LUZON, INCORPORATED FOR THE RENEWAL OF THE PROVISION OF BROADCASTING FACILITIES FOR THE WEEKLY AIRING OF THE TRAVEL MAGAZINE SHOW “GANDA MO PANGASINAN”**

**WHEREAS**, it is the objective of the Provincial Government of Pangasinan to reach wider audience and disseminate information to the public as fast and as accurate as possible by using modern technology;

**WHEREAS**, pursuant to Provincial Resolution No. 725-2024, dated August 5, 2024, the Sangguniang Panlalawigan has authorized the Provincial Governor, Ramon V. Guico III, to enter into and sign a Contract with Regional News Group (RNG) Luzon, Incorporated, for the renewal of the provision of broadcasting facilities for the Travel Magazine Show “Ganda Mo Pangasinan”;

**WHEREAS**, for two consecutive years, the Regional News Group (RNG) Luzon, Incorporated has satisfactorily provided the agreed-upon broadcasting facilities, enabling the Province of Pangasinan to effectively deliver and provide the people with trusted and objective news, information, and cultural programming through the Internet, mobile and social media and television;

**WHEREAS**, in a letter addressed to the Provincial Governor, Ramon V. Guico III, dated June 16, 2025, the Regional News Group (RNG) Luzon, Incorporated, has signified its intention to continue its partnership with the Provincial Government of Pangasinan to help boost the tourism industry of the Province through the Travel Magazine Show “Ganda Mo Pangasinan”;

**WHEREAS**, the renewal of the contract is in the best interest of the Provincial Government of Pangasinan as it ensures the continuity of the implementation of various programs and projects on information and media relations of the Province;

**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;



**NOW, THEREFORE**, on motion of SP Member Noel Fernando R. Bince, Jr., duly seconded, it was –


