**PROVINCIAL RESOLUTION NO. 883-2025**

**AUTHORIZING THE PROVINCIAL GOVERNMENT OF PANGASINAN THROUGH PROVINCIAL GOVERNOR RAMON V. GUICO III, PROVINCIAL TREASURER CRISTY C. UBANDO AND MS. CATHERINE DELA CRUZ CAMBA, OFFICER-IN-CHARGE, OFFICE OF THE PROVINCIAL ACCOUNTANT, TO ENROL AND SUBSCRIBE IN THE INSTITUTIONAL INTERNET BANKING FACILITY, KNOWN AS "WeAccess" OF THE LAND BANK OF THE PHILIPPINES**

**WHEREAS**, the Provincial Government of Pangasinan maintains deposit accounts with the Land Bank of the Philippines – Lingayen Branch;

**WHEREAS**, the banking industry has embraced technological advancements to improve efficiency and convenience in financial transactions;

**WHEREAS**, the Land Bank of the Philippines offers an institutional internet banking facility, known as "weAccess", which enables government agencies to transact with the bank online, providing a secure and more efficient means of conducting financial transactions;

**WHEREAS**, the Provincial Government of Pangasinan recognizes the necessity of enrolling in the online facility services of the Land Bank of the Philippines as this will significantly streamline its financial operations, including, but not limited to, the digital payment of government disbursements and the collection of fees, consistent with modern governance practices;

**WHEREAS**, the authorized signatories and users for the said facility are as follows:

1. Honorable Ramon V. Guico III – Provincial Governor
2. Ms. Cristy C. Ubando – Provincial Treasurer
3. Ms. Catherine Dela Cruz Camba – Officer-in-Charge, Office of the Provincial Accountant

**WHEREAS**, the abovementioned official signatories and users shall also be authorized to:

1. Execute/sign all documents necessary to subscribe to LBP's "weAccess";
2. Designate/authorize personnel who will act as "maker" or "authorizer" for the company's access to LBP's "weAccess" banking facility;
3. Amend/add/delete enrolled deposit account/s as source and/or destination account/s, access rights to the "weAccess" modules, authorization rules and/or any information on the original and succeeding enrollments.


**WHEREAS**, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –


