**RESOLUTION NO. 1003-2025**

**DECLARING ORDINANCE NO. 2025-16 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR MONTHLY TRANSPORTATION ALLOWANCE TO ELIGIBLE/QUALIFIED PRESIDENTS OF THE BARANGAY ASSOCIATIONS OF SENIOR CITIZENS AFFAIRS IN THE CITY OF ALAMINOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2025-16 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with R.A. No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010; Sections 16, 17(b)(4), 458 (a)(5)(xiv)(xvii) of R.A. No. 7160”; Article XV, Section 4 of the Philippine Constitution;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-16 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled, “An Ordinance providing for monthly transportation allowance to eligible/qualified Presidents of the Barangay Associations of Senior Citizens Affairs in the City of Alaminos, Pangasinan” as within the conferred powers of the Sangguniang Panlungsod to enact;




