RESOLUTION NO. 89-2026

DECLARING MUNICIPAL ORDINANCE NO. 2025-011 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED, "RECOGNITION AND INCENTIVES TO BOARD OR BAR EXAMINATION TOPNOTCHERS WHO ARE RESIDENTS OF THE MUNICIPALITY OF LAOAC, PANGASINAN AND PROVIDING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Ordinance No. 2025-011 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province has conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of Republic Act No. 7160;

WHEREAS, the Local Government Unit through its Local Finance Committee will make sure that funding for this will be appropriated in order to properly implement the ordinance;

WHEREFORE, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2025-011 of the Sangguniang Bayan of Laoac, Pangasinan, entitled, "Recognition and incentives to Board or Bar Examination Topnotchers who are residents of the Municipality of Laoac, Pangasinan and providing funds therefor" as within the conferred powers of the Sangguniang Bayan to enact;




