DECLARING MUNICIPAL ORDINANCE NO. 2025-01 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AMENDING SECTION 3, NUMBER 9 OF MUNICIPAL ORDINANCE NO. 2020-07 OF THE MUNICIPALITY OF BUGALLON, CHANGING THE TITLE POSITION FROM INTERNAL AUDITOR V, SG 24 TO MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (INTERNAL AUDITOR V), SG 24” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT
