**RESOLUTION NO. 914-2025**

**DECLARING MUNICIPAL ORDINANCE NO. 2025-001 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “DECLARING AND CITING JUNE 17, 1972, AS THE FOUNDATION DAY OF THE MUNICIPALITY OF LAOAC, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Municipal Ordinance No. 2025-001 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of R.A. No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-001 of the Sangguniang Bayan of Laoac, Pangasinan, entitled “Declaring and citing June 17, 1972, as the Foundation Day of the Municipality of Laoac, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;


