RESOLUTION NO. 957-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CALENDAR YEAR 2025 OF MANAOAG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P34,863,014.35, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 01 for Calendar Year 2025 involving total appropriations of P34,863,014.35 which was enacted on August 19, 2025 through Appropriation Ordinance No. 01, Series of 2025;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, has conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

3. That all procurements to be undertaken shall be subject to the existing laws, rules, and regulations;
4. That the utilization of appropriations from shares of the LGU from the FY 2022 Collections of Burley and Native Tobacco Excise Tax under RA No. 8240 as amended, chargeable against the FY 2024 GAA, RA No. 11975 (LBM No. 91, dated August 29, 2024); and
5. That the purchase of motor vehicle shall be in accordance with the provisions of DBM Budget Circular No. 2022-1 dated February 11, 2022 re: Omnibus Guidelines on the Acquisition, Use, Rental & Replacement of Government Motor Vehicles.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 01 for Calendar Year 2025 of Manaoag, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Manaoag, Pangasinan, for its information and guidance.
