PROVINCIAL RESOLUTION NO. 971-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION AND ACCEPT THE FINANCIAL ASSISTANCE FROM THE OFFICE OF THE PRESIDENT, FERDINAND R. MARCOS, JR., IN THE TOTAL AMOUNT OF FIFTY MILLION PESOS (PHP50,000,000.00) FOR THE RECOVERY AND REHABILITATION EFFORTS IN THE PROVINCE DUE TO THE DEVASTATION CAUSED BY SUPER TYPHOON “UWAN”

WHEREAS, the Province of Pangasinan experienced the severe impact and devastation caused by Super Typhoon “Uwan”, resulting in significant damage to infrastructure, agriculture, and the displacement of numerous households and communities;

WHEREAS, the Provincial Government of Pangasinan is committed to undertake the immediate recovery and rehabilitation of the communities and addressing the needs of its constituents;

WHEREAS, the President of the Republic of the Philippines, through the Office of the President, has extended financial assistance to local government units affected by the recent calamity to aid in the post-calamity response;

WHEREAS, the Office of the President is donating to the Provincial Government of Pangasinan the total amount of Fifty Million Pesos (P50,000,000.00), sourced from the Socio-Civic Projects Fund, for the benefit of the affected populace and rehabilitation of the Province following the onslaught of Super Typhoon “Uwan”;

WHEREAS, the Provincial Government of Pangasinan hereby expresses its gratitude and willingness to accept the said financial assistance from the Office of the President;

WHEREAS, the said donation shall be utilized strictly for the intended purpose as stipulated in the Deed of Donation, subject to pertinent laws, and all government accounting and auditing rules and regulations;

WHEREAS, a Deed of Donation must be executed and signed by the Provincial Governor for and on behalf of the Province of Pangasinan to formalize the grant of and acceptance of the said financial assistance;

WHEREAS, the Local Government Code of 1991 and other pertinent laws authorize the Provincial Governor, as Chief Executive, to enter into contracts and agreements on behalf of the Provincial Government, subject to the authorization of the Sangguniang Panlalawigan;


WHEREAS, for the above purpose, a Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Office of the President, through its duly authorized representative;

NOW, THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Deed of Donation and accept the financial assistance from the Office of the President, Ferdinand R. Marcos, Jr., in the total amount of Fifty Million Pesos (Php50,000,000.00) for the recovery and rehabilitation efforts in the Province due to the devastation caused by Super Typhoon “Uwan”;
