**PROVINCIAL RESOLUTION NO. 988-2025**

**APPROVING THE ISSUANCE OF CERTIFICATE OF RECOGNITION TO THE VARIOUS CIVIL SOCIETY ORGANIZATIONS (CSOs) IN THE PROVINCE AS PROVIDED UNDER THE LOCAL GOVERNMENT CODE OF 1991**

**WHEREAS**, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 23, 2025, the Department of the Interior and Local Government issued Memorandum Circular No. 2025-060 providing the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

**WHEREAS**, the following Civil Society Organizations, through their respective Presidents, have signified their intention to be recognized in the Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation-building;

**NOW, THEREFORE**, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was—


