## EXECUTIVE ORDER NO. <u>6002</u> - 2023

## APPOINTMENT OF JOSE MARIA V. VIRAY AS THE AUTHORIZED REPRESENTATIVE OF THE PROVINCE OF PANGASINAN/ EX-OFFICIO MEMBER TO THE PANGASINAN CREDIT SURETY FUND

WHEREAS, the Credit Surety Fund Program (CSF) is a credit enhancement scheme developed by the Bangko Sentral ng Pilipinas (BSP) which aims to increase the credit worthiness of micro, small and medium enterprises (MSMEs) that are experiencing difficulty in obtaining loans from banks due to lack of acceptable collaterals, credit knowledge and credit track records;

WHEREAS, in May 2011, a Memorandum of Agreement was entered into by the Provincial Government of Pangasinan, Bangko Sentral ng Pilipinas, Cooperatives/NGOs, Development Bank of the Philippines, Land Bank of the Philippines and Industrial Guarantee and Loan Fund to create a trust fund to be known as the Pangasinan Credit Surety Fund;

**WHEREAS**, the fund shall serve as a security for loans of MSMEs from banking institutions by providing a surety cover in lieu of acceptable collaterals;

WHEREAS, the above Memorandum of Agreement provides that each member of the PCSF shall designate in writing, one of its incumbent officials as its authorized representative/exofficio member and alternate who shall attend the general and/or special meetings of the Members of the PCSF;

**NOW THEREFORE, I, RAMON V. GUICO III,** Governor of the Province of Pangasinan, by virtue of the powers vested in me by law, do hereby order as follows:

**Section 1.** Appoint Mr. Jose Maria V. Viray as the new representative of the Province of Pangasinan to the PCSF. Mr. Viray shall perform his functions as such until a new representative is properly designated in writing by the governor or his authorized representative. Likewise, Mr. Viray is hereby directed to attend the general and/or special meetings of the Members of the PCSF as one of its Ex-officio Members and render regular report to the Office of the Governor and/or Office of the Provincial Administrator.

**Section 2.** Mr. Ellsworth G. Gonzales, Pangasinan Provincial Cooperative and Livelihood Development (PPCLD) Officer and the former authorized representative of the Province of Pangasinan/Ex-Officio member of the PCSF is hereby directed to make a proper turnover of records or documents relative to PCSF with Mr. Jose Maria V. Viray, as the new representative of the Province of Pangasinan to the PCSF.

This Order shall take effect immediately and shall continue to be in force until revoked in writing.
