EXECUTIVE ORDER NO. 0005, SERIES OF 2023

AN ORDER IMPLEMENTING A TEMPORARY TOTAL BAN ON THE ENTRY OF ALL DUCKS, QUAILS, SPENT HENS (CULLED), HATCHING EGGS, PIGEONS, GAMEFOWLS, READY TO LAY PULLET (RTL), AND THE RESTRICTIONS ON THE MOVEMENT OF OTHER POULTRY BIRDS AND BY PRODUCTS FROM THE PROVINCES OF BULACAN, PAMPANGA, NUEVA ECIJA, TARLAC, LAGUNA, SULTAN KUDARAT, BENGUET, NORTH COTABATO, SOUTH COTABATO, MAGUINDANAO, ISABELA, RIZAL, QUEZON, KALINGA, AURORA, ILOCOS NORTE, ILOCOS SUR INTO THE PROVINCE OF PANGASINAN

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution and Section 16 of the Local Government Code of 1991 provides that Local Government Units within their territorial jurisdiction shall promote health and safety of the people;

WHEREAS, Executive Order No. 0196-2022 was issued on October 27, 2022 implementing a temporary total ban on the entry of all ducks, quails, spent hens (culls), and chicken layers into the province of Pangasinan from October 26, 2022 to December 31, 2022;

WHEREAS, to date, Pangasinan has no reported cases of Avian Influenza Subtype H5N1, however, there is a need to implement a temporary total ban on the entry of all Ducks, Quails, Spent Hens (Culled), Hatching Eggs, Pigeons, Gamefowls, and Ready to Lay Pullet (RTL), strengthen regulatory services, boarder control on the intra and inter provincial movement of animals, and intensify quarantine activities within the Province of Pangasinan, to maintain its present status.

NOW, THEREFORE, I, RAMON V. GUICO III, Governor of the Province of Pangasinan, Philippines, by virtue of the powers vested in me, do hereby order the following, to wit:

SECTION 1. Temporary Total Ban on The Entry of All Ducks, Quails, Spent Hens (Culled), Hatching Eggs, Pigeons, Gamefowls, Ready to Lay Pullet (RTL), and the Restrictions on the Movement of other Poultry Birds and By Products from the provinces of Bulacan, Pampanga, Nueva Ecija, Tarlac, Laguna, Sultan Kudarat, Benguet, North Cotabato, South Cotabato, Maguindanao, Isabela, Rizal, Quezon, Kalinga, Aurora, Ilocos Norte, Ilocos Sur into the Province of Pangasinan from February 2, 2023 to March 2, 2023, to prevent the possible entry of the virus.

SECTION 2. To allow the entry of poultry products into the province, the following requirements in the Animal Quarantine Checkpoints must be complied with, to wit:

a. Broiler

- i. Veterinary Health Certificate;
- ii. Veterinary Shipping Permit;
- iii. Animal Welfare Registration Certificate;
- iv. Certificate of Disease-Free Status-A1;

- v. Handler's License Certificate of Registration;
- vi. Transport Carrier Registration Certificate.
- b. Day Old Chick Hatching Eggs
 - i. Certificate of Acceptance from LGU of Destination;
 - ii. Veterinary Health Certificate;
 - iii. Veterinary Shipping Permit;
 - iv. Animal Disease Monitoring Compliance Certificate (ADMCC) Handler's License Certificate of Registration;
 - v. Transport Carrier Registration Certificate.
- c. Eggs (Table Eggs, Salted Eggs, Quail eggs, Embryonated Eggs/Balut)
 - i. Veterinary Shipping Permit;
 - ii. Certificate of Disease-Free Status-A1 of Source Farm;
 - iii. Livestock Handler's License Certificate of Registration;
 - iv. Transport Carrier Registration Certificate.
- d. Fresh Poultry Meat and Frozen Poultry Meat
 - i. Certificate of Meat Inspection (Imported);
 - ii. Meat Inspection Certificate (Local);
 - iii. Veterinary Shipping Permit.

SECTION 3. Violation of this Order shall be tagged as blacklist, and no longer be allowed to transact business on livestock and poultry shipment in the province.

SECTION 4. The Provincial Veterinarian Quarantine Officers, Local Philippine National Police (PNP) are hereby empowered to enforce the restrictions of this Order in border checkpoints around the Province of Pangasinan. Further, all Local Chief Executives are likewise directed to assist the implementation of this Order in their respective jurisdiction.

SECTION 5. All previous Executive Orders, memoranda, and other issuances or parts thereof which are inconsistent herewith are hereby revoked, amended, or modified accordingly.

SECTION 6. This order shall take effect immediately.
