EXECUTIVE ORDER NO. 0006, Series of 2023

**RECONSTITUTING THE PROVINCIAL NUTRITION COMMITTEE
IN THE PROVINCE OF PANGASINAN**

WHEREAS, Presidential Decree No. 491, Series of 1974, Creating a National Nutrition Council and for other Purposes and shall be known as the Nutrition Act of the Philippines;

WHEREAS, in Section 2, under the declaration of Policy, the Government of the Philippines hereby declared that nutrition is priority to be implemented by all branches of the government in an integrated function;

WHEREAS, the delivery of basic services including nutrition is devolved to the Local Government Units (LGUs);

WHEREAS, pursuant to Letter of Instructions No. 441, series of 1976, the Department of Interior and Local Government (DILG) is authorized to establish functioning nutrition committees at different administrative levels in barangay, municipality, city, province and region;

WHEREAS, the DILG requires for the assessment of the functionality of Provincial, Municipal & Barangay Nutrition committee.

NOW, THEREFORE, I, RAMON V. GUICO III, Governor of Pangasinan by virtue of the powers vested in me by law, do hereby reconstitute the Provincial Nutrition Committee in the Province of Pangasinan composed as follows:


The Provincial Nutrition Committee shall discharge the following functions, to wit:

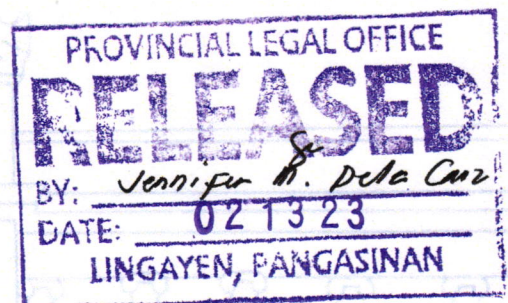



Dear Dr. De Guzman:

Reference is made to your request for review/ legal opinion on the proposed Executive Order No. _____, Series of 2022, entitled: **“Reconstituting the Provincial Nutrition Committee in the Province of Pangasinan”**.

The subject Executive Order is consistent with Presidential Decree No. 491 of 1974 or the Nutrition Act of the Philippines, which created the National Nutrition Council (NNC). The NNC supervises, coordinates and evaluates the implementation of the national nutrition program which shall be implemented by all agencies and instrumentalities of both the government and the private sector concerned with improving the nutrition of the people. The NNC continues to adhere to its mandate in orchestrating efforts of government, private sector, capacity development, promotion of good nutrition, and nutrition surveillance in addressing hunger and malnutrition of Filipinos through policy and program formulation and coordination, resource generation and mobilization, advocacy and partnership, and alliance building.


However, a minor typographical error was observed in the 2nd paragraph of the Whereas Clause with the use of the term “function”. The undersigned humbly suggests a rectification of the provision to conform with Section 2 of PD 491, which reads:

“Sec.2. Declaration of Policy. – The Government of the Philippines hereby declares that nutrition is now a priority of the government to be implemented by all branches of the government in an integrated **fashion**.”

Moreover, the undersigned notes the written designation of Ms. Dolores U. Vinoya and Engr. Rowena V. Ignacio, as **Acting** Provincial Budget Officer and **Acting** Provincial Planning and Development Coordinator, respectively. Rectification is also requested in order to reflect the correct designation of their position, both being the **Officer-in-Charge** of the respective Offices.

There appears to be no legal impediment in the other provisions of the draft Executive Order. After consideration of the above observations, we respectfully recommend the issuance of the same.
