EXECUTIVE ORDER NO. 0007-A Series of 2023

AMENDING EXECUTIVE ORDER NO. 0150 - 2022 RECONSTITUTING THE PROVINCIAL DEVELOPMENT COUNCIL (PDC) OF THE PROVINCE OF PANGASINAN

WHEREAS, Executive Order No. 0150-2022 reconstituted the Provincial Development Council (PDC) of the Province of Pangasinan;


