#### **EXECUTIVE ORDER NO. 0011, SERIES OF 2023**

## CREATING THE PROVINCIAL INTER-AGENCY COMMITTEE ON RELOCATION & RESETTLEMENT IN THE PROVINCEOF PANGASINAN

WHEREAS, the Local Government Code of 1991 (RA 7160) and the Urban Development and Housing Act of 1992 (RA 7279) are two (2) landmark legislations that mandated Local Government Units (LGUs) to take the principal role in the delivery of shelter and the provision of basic services to homeless and underprivileged families;

WHEREAS, one of the priority development thrust of the Provincial Government of Pangasinan, under its vision of a "Slum-Free Pangasinan", is the provision of decent and affordable shelter and the development of viable housing communities for its constituents;

WHEREAS, the Provincial Government of Pangasinan and the various housing stakeholders commit themselves to address the needs of the informal settler families living in danger areas, families affected by natural disasters and calamities and those displaced by government infrastructure projects;

WHEREAS, there is a need to create a Provincial Local Inter-Agency Committee on Relocation and Resettlement to serve as the focal structure and clearing house for relocation and resettlement activities and issues in the province;

**NOW, THEREFORE, I, RAMON V. GUICO III**, Governor of Pangasinan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION AND COMPOSITION. The Provincial Inter-Agency Committee on Relocation and Resettlement ("PIAC on Relocation & Resettlement" for brevity) is hereby created, and it shall be composed of the following, to wit:

All members of the PIAC for Resettlement & Relocation are hereby directed to name their respective permanent and alternate representatives who shall take their place in case of their absence.

# SECTION 2. GENERAL FUNCTIONS OF THE PIAC ON RESETTLEMENT & RELOCATION

- a. Supervise the conduct of tagging of structures and census / occupancy verification of households and related socio-economic survey;
- b. Monitor the activities of the Beneficiary Selection, Arbitration and Awards Committee;
- c. Facilitate the conduct of community consultation, information-motivation and community relation activities, e.g. production and dissemination of information materials, community assemblies, leader's meetings, etc.
- d. Recommend appropriate relocation / resettlement package and other entitlements for the affected families;
- e. Formulate relocation and resettlement work plan;
- f. Oversee the mobilization of resources necessary to ensure smooth, orderly and efficient relocation and resettlement operations;
- SECTION 3. SECRETARIAT. The Provincial Housing & Urban Development Coordinating Office (PHUDCO) is hereby directed as the Secretariat of the PIAC on Relocation & Resettlement, and shall be tasked to handle all its administrative and secretariat functions.
- SECTION 4. PIAC SUB-COMMITTEES. The PIAC on Relocation and Resettlement shall be composed of seven (7) sub-committees to address various concerns of relocation and resettlement, to wit:

#### 1. SUB-COMMITTEE ON RELOCATION AND RESETTLEMENT

- Takes charge of resettlement options, prepares resettlement package and alternative programs, prepares work plans and project cost.

- Provide accurate data thru comprehensive profiling of families to be relocated.

- SECTION 6. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 7. REPEALING CLAUSE. All orders or parts thereof which are inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Executive Order shall take effect immediately.
