#### **EXECUTIVE ORDER NO. 0014 Series of 2023**

REORGANIZING THE PROVINCIAL LOCAL PLANNING AND EXPENDITURE MANAGEMENT (PLPEM) CORE TEAM FOR THE UPDATING OF THE 2018-2027 DRR-CCA ENHANCED PROVINCIAL DEVELOPMENT AND PHYSICAL FRAMEWORK PLAN AND PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM OF THE PROVINCE OF PANGASINAN

WHEREAS, DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, series of 2016 updated the harmonization planning, investment programming, revenue administration, budgeting and expenditure management at the local levels;

WHEREAS, Executive Order No. 0141-2017 reorganized the PLPEM Core Team created under Executive Order No. 0070-07-2007, which was responsible in the updating of the DRR-CCA Enhanced PDPFP and its accompanying document, the Provincial Development Investment Program (PDIP) 2018-2027;

WHEREAS, the DRR-CCA Enhanced PDPFP contains the province's long term vision, development goals, strategies, objectives/targets and corresponding programs, projects and activities responsive of the disaster risk reduction and climate change adaptation which serves as the policy direction of the component local government units in the formulation of their Comprehensive Land Use Plans and Comprehensive Development Plans;

WHEREAS, the need to update the existing PDPFP and PDIP is necessary to integrate the vision, mission and strategic direction of the current administration as well as to align it with the 2023-2028 Philippine Development Plan;

WHEREAS, there is a need to reorganize the Provincial PLPEM Core Team which will act as an over-all planning and coordination group in the updating of both the PDPFP and PDIP;

**NOW, THEREFORE, I, RAMON V. GUICO III**, Governor, Province of Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize the Provincial Local Planning and Expenditure Management (PLPEM) Core Team of the Province of Pangasinan with the following composition and functions, to wit:
