**ADOPTION OF THE LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) AS
THE STRATEGIC AND INVESTMENT PLAN OF THE PROVINCE-WIDE HEALTH
SYSTEMS (PWHS)**

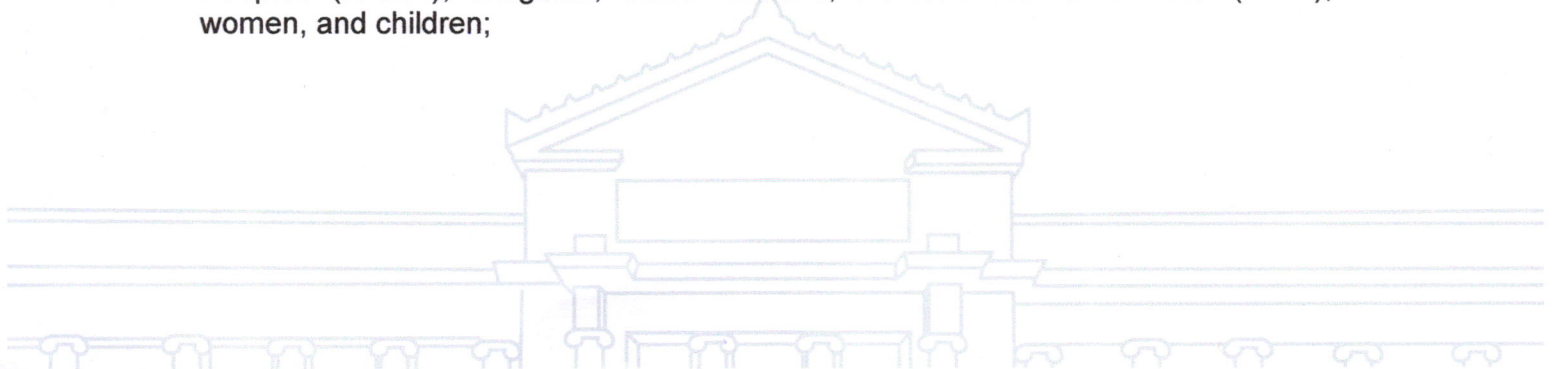
WHEREAS, the Local Investment Plan for Health (LIPH) is a medium-term public investment plan for health that specifies the strategic direction of the Province-Wide Health Systems in terms of improving health service delivery, strengthening the health systems operations and addressing social determinants of health, and specifies actions and commitments of different local stakeholders;

WHEREAS, the LIPH and its Annual Operational Plans (AOP) reflect the collaborative and collective efforts of the health sector and various stakeholders, including the private sector, and is the key instrument in forging the Department of Health (DOH) and the Province-Wide Health Systems partnership to implement the Universal Health Care;

WHEREAS, the LIPH is translated into Annual Operational Plans (AOP);

WHEREAS, the LIPH and AOP, undergo a bottom-up planning procedure that allow lower level units to have their plans incorporated in the Province-Wide health plan;

WHEREAS, the LIPH and AOP, address the health needs of the majority of the local population and equally provide consideration to the health needs of the vulnerable population such as, but not limited to, population in Geographically Isolated and Disadvantaged Areas (GIDA), Indigenous Cultural Communities/ Indigenous Peoples (ICC/IP), indigents, senior citizens, Persons with Disabilities (PWD), women, and children;




WHEREAS, the PWHS, along with its 3 component cities and 44 municipalities, commits to deliver the programs/projects/activities contained in the LIPH and its AOPs. The LIPH/AOP will be used as the basis for health inputs to the Regional Development Plan (RDP), the Local Development Investment Program (LDIP)/Comprehensive Development Plan (CDP), Annual Investment Plan (AIP), and other health-related LGU mandated plans.

NOW, THEREFORE, I, RAMON V. GUICO III, Governor, Province of Pangasinan, by powers vested in me by law, do hereby order the adoption of the Local Investment Plan for Health as the strategic and investment plan for health of the PWHS and the corresponding AOPs of the LIPH as the yearly operational and investment plan for health of the PWHS.

This order shall take effect immediately
