### EXECUTIVE ORDER NO. 0058, series of 2023

AN ORDER EXTENDING THE TEMPORARY TOTAL BAN ON THE ENTRY OF LIVE SWINE/PIGS, PORK, AND PORK BY-PRODUCTS FROM ALL CITIES AND MUNICIPALITIES UNDER RED ZONE INTO THE PROVINCE OF PANGASINAN FROM JULY 1, 2023 TO SEPTEMBER 30, 2023

WHEREAS, the State is mandated to protect and promote the right to health of the people under Article 2, Section 15 of the 1987 Philippine Constitution, and LGUs are empowered to exercise necessary, appropriate and incidental powers for its efficient governance in promotion of general welfare, as provided by Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, according to recent data of the Bureau of Animal Industry, there are reported cases of African Swine Fever in the province, specifically, in the Municipalities of Anda and Bolinao, and in the City of Alaminos;

**WHEREAS**, there must be a continuous effort to address and contain the spread of ASF for the welfare of the residents, and to prevent or eliminate ASF threat in the province.

**NOW, THEREFORE, I, RAMON V. GUICO III,** Governor of the Province of Pangasinan, Philippines, and by virtue of the powers vested upon me by the law, do hereby further extend the Executive Order No. 15-A, series of 2023 from July 1, 2023 to September 30, 2023.

Section 1. All necessary documentary requirements in the Animal Quarantine Checkpoints mentioned in Executive Order No. 0015-A, series of 2023, are hereby reiterated, as follows:

- a. Live Pigs for Slaughter
  - i. Veterinary Health Certificate;
  - ii. BAI Shipping Permit;
  - iii. Animal Welfare Registration Certificate;
  - iv. Transport Carrier Registration Certificate;
  - v. Handler's License Certificate;
  - vi. Certificate of Free Status-ASF/ASF Laboratory Negative Result;
  - vii. Certificate of Acceptance.
- b. Live Pigs for Breeding Purposes
  - i. Animal Welfare Registration Certificate;
  - ii. Bureau of Animal Industry Accredited Swine Breeder Farm Certificate;
  - iii. Veterinary Health Certificate;

- iv. BAI Shipping Permit;
- v. Transport Carrier Registration Certificate;
- vi. Handler's License Certificate;
- vii. Certificate of Free Status-ASF/ASF Laboratory Negative Result;
- viii. Certificate of Acceptance.

#### c. Semen

- i. Bureau of Animal Industry Accredited Swine Breeder Farm Certificate;
- ii. Veterinary Health Certificate;
- iii. BAI Shipping Permit;
- iv. Laboratory Negative Result (PRRS, Pseudorabies, Brucellosis);
- v. Certificate of Free Status-ASF, RT-PCR Elisa negative result;
- vi. RT-PCR Elisa Negative Test;
- vii. Certificate of Acceptance.
- d. Fresh/Frozen Pork Meat and Meat By-Products
  - i. Certificate of Meat Inspection (Imported);
  - ii. Meat Inspection Certificate (Local);
  - iii. BAI Shipping Permit;
  - iv. Certificate of Acceptance.
- e. Uncooked Processed Pork Products
  - i. License to Operate (LTO);
  - ii. Certificate of Product Registration (CPR) issued by FDA;
  - iii. BAI Shipping Permit;
  - iv. Certificate of Acceptance.
- f. Cooked Processed Meat Products
  - i. License to Operate (LTO);
  - ii. Certificate of Registration issued by FDA;
  - iii. BAI Shipping Permit;
  - iv. Certificate of Acceptance.
- Section 2. **ALL TRANSHIPMENTS** going to Ilocos Sur, Ilocos Norte, La Union, Abra, and Benguet shall take TPLEX Urdaneta Exit.
- Section 3. All other executive issuance, rules and regulations or parts thereof which are inconsistent with this Order are hereby revoked, amended, or modified accordingly.
- Section 4. This Executive Order shall take effect immediately and shall remain in force until subsequently amended/revoked/revised.
