#### PROVINCIAL RESOLUTION NO. 1-2021

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE OFFICE OF CIVIL DEFENSE REGIONAL OFFICE 1 FOR THE ALLOCATION OF FUNDS OF THE ISOLATION FACILITIES LOCATED IN OPAG-STA. BARBARA STATION AND IN THE PANGASINAN REFORMATION CENTER – BURGOS, PANGASINAN

**WHEREAS**, two (2) government-owned buildings of the Province of Pangasinan located in OPAg-Sta. Barbara Station and in the Pangasinan Reformation Center – Burgos, Pangasinan have been converted by the Department of Public Works and Highways into isolation facilities (Ligtas COVID-19 Centers);

WHEREAS, the Maintenance and Other Operating Expenses (MOOE) for the said facilities will be provided by the Office of the Civil Defense Regional Office 1 in the amount of P4,394,066.67 for OPAg-Sta. Barbara and P4,040,266.67 for Pangasinan Reformation Center – Burgos;

**WHEREAS,** allocation of funds for the maintenance of the said facilities is provided under Section 10 of RA 11494, otherwise known as "Bayanihan to Recover as One Act";

**WHEREAS,** the funds will be used to support the operations of the facilities specifically for food for the patients and workers, decontamination of the facilities, wastes management, transport services, supplies and materials, ICT equipment, and hiring of utility workers;

WHEREAS, in regard to the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino III and the Office of Civil Defense Regional Office 1, represented by Regional Director Eugene G. Cabrera;
